PROPOSED ORDER

Considering the Limited Admission of Regulatory Responsibility for Environmental Damage ("Limited Admission") filed by Ichor Energy (LA) LLC ("Ichor") and Petrodome Operating, LLC ("Petrodome"), together with the *Ex Parte* Motion for Mandatory Referral to the Louisiana Department of Energy and Natural Resources for Development of the Most Feasible Plan Pursuant to La. R.S. 30:29:

IT IS HEREBY ORDERED, ADJUDGED AND DECREED THAT:

(1) Pursuant to La. Code Civ. P. art 1563, Ichor and Petrodome have made a limited admission of responsibility for the environmental damage, as defined by La. R.S. 30:29(T)(1), on that area of the property affected by the December 26, 2021 flowline leak and shown within the area outlined in yellow on Exhibit A to the Limited Admission.

(2) Ichor and Petrodome's Limited Admission is limited to "responsibility for implementing the most feasible plan to evaluate, and if necessary, remediate all of a portion of the contamination that is subject to the litigation to the applicable regulatory standards" within the area outlined in yellow on Exhibit A.

(3) The Limited Admission is not an admission of liability for any of the plaintiffs' private claims and is not to be construed as a waiver of any affirmative defenses.

(4) Ichor and Petrodome shall develop a plan for the evaluation and, if necessary, the remediation of "environmental damage" to "applicable regulatory standards," as provided in La. R.S. 30:29(C), of the area of the property outlined in yellow on Exhibit A.

(5) Ichor's and Petrodome's plan, as described above, shall be developed and submitted to the Louisiana Department of Energy and Natural Resources by certified mail with return receipt requested on or before October 3, 2025, together with a deposit of ONE HUNDRED

THOUSAND AND NO/100 DOLLARS (\$100,000.00) to defray LDENR's cost of responding to this Court's referral for development of the most feasible plan. By this date, Ichor and Petrodome shall also file into the record of this Court a copy of the submission to LDENR.

(6) The plaintiffs shall have thirty (30) days from the date the plan is filed to review Ichor's and Petrodome's plan and submit to the Louisiana Department of Energy and Natural Resources and the Court any comments on the plan, any input on the plan or on the LDENR's process and/or their own proposed plan.

(7) The Louisiana Department of Energy and Natural Resources shall submit to the Court a schedule of estimated costs for review of the plans or submittals of the parties.

(8) Any further proceedings with respect to the plan submitted by Ichor & Petrodome, before the Louisiana Department of Energy and Natural Resources, shall be conducted pursuant to the procedures set forth in La. R.S. 30:29.
